Dear [],

Thank you for your Freedom of Information Request received on 29 August 2023. For information, the AHSN Network is not a legal entity, it is an affiliation of 15 local AHSNs. I am, however, able to provide a response as the AHSN Network Co-ordination Director on behalf of the 15 AHSNs in respect of the information held jointly. In some instances, information requested relates to one of the individual member AHSNs, and your request has been forwarded to them for their specific response.

Some of the information requested relates to third parties and/or is likely to relate to or affect the interests of third parties and so we are consulting with them in accordance with the Section 45 Code of Practice. This is therefore the first stage of the AHSN Network's response, and we will provide a further response when we have completed the consultation process, which we anticipate will be complete by 19 October.

1. Copies of any due diligence and/or evaluation work held by the AHSN.

The AHSN Network has previously published responses to questions on due diligence and evaluation. These are available on the Network's FOI disclosure log on the AHSN Network website, here: Freedom of Information - The AHSN Network. See Serenity Integrated Mentoring (SIM) and High Intensity Network FOI Part II response letter, 3 September and, in particular responses to questions 2,3,4 and 7. In addition, in May 2023, the AHSN Network published an independent review into its role in supporting the adoption of SIM. 2. A copy of the agreement under which Sergeant Paul Jennings was seconded to NHS England as a result of his 2016 NHS Innovation Accelerator award.
